AMENDED NOTICE OF APPEAL

Walter Louis Brown appeals his conviction and sentence in this case. The sentence was imposed by the Honorable Judge Clifton Newman on November 2, 2012. The Defendant filed a Motion to Reconsider the Sentence. This hearing was heard on April 2, 2015. On July 25, 2015, the Court issued a ruling denying the Defendant's Motion. The Clerk of Court hand-delivered a copy of the Court's Order Denying Defendant's Motion for Reconsideration on August 12, 2015. The Defendant filed a timely notice of appeal but did not include an issue for appeal.
