1. The undersigned attorney for Francis Larmand hereby certifies that his client has reviewed this Return and is in full agreement with the Return.


2. Mr. Larmand again acknowledges that he understands the conditions of his release on appeal bond and stands ready and willing to fully comply with all the terms.
