On September 2, 2015, the undersigned attorney received letters dated August 25, 2015, from Deputy Clerk V. Claire Allen advising that a motion requesting permission to file the transcript request out of time was necessary in order to avoid dismissal of the above referenced appeals. Although the letters are dated August 25, 2015, the correspondence was not received by the undersigned until September 2, 2015, thus giving the undersigned attorney only two days in which to comply with the Court's request.

The above referenced matters involve an appeal to the Circuit Court with regard to an appeal from the South Carolina Workers' Compensation Commission. The parties did not introduce any evidence during the oral argument before the Circuit Court. Hence, the proceedings before the Circuit Court involved only arguments of counsel, which would not be part of the appellate record. Hence, the hearing transcript is not necessary in order to perfect the Record on Appeal; nor is it anticipated that the transcript would be used to make any arguments to the Court. A transcript of the Circuit Court proceedings, therefore, was not requested.

Nonetheless, in an effort to avoid the dismissal of the appeal, the undersigned shall request a copy of the transcript of record before the Circuit Court (copy of letter attached). Again, a delay in processing the appeal predicated upon receipt of the transcript is not necessary.

Accordingly, it is respectfully submitted that the Court permit Counsel for Arrowpoint Capital Corporation and Liberty Mutual Insurance Company to file the copy of the transcript request to the Circuit Court reporter out of time.

Second, in the interest of judicial economy, the undersigned respectfully requests that the Appellate Case matters as referenced above be combined for one appeal. The collective arguments in both cases were heard and recorded simultaneously by the Circuit Court.

Finally, with regard to Appellate Case No. 2015-001706, the caption is in error. The caption should be amended to reflect that Liberty Mutual Insurance Company is the Appellant in that particular matter. Arrowpoint Capital Corporation is the Appellant in Appellate Case No. 2015-001704. It appears that this error was caused by the improper designation on the Circuit Court Order.

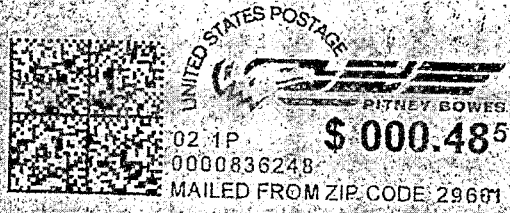
