
Respondent Grand Strand Regional Medical Center, LLC (Grand Strand), Appellant Carolina Regional Cancer Center (CRCC), and the South Carolina Department of Health and Environmental Control (Department) (collectively, the Parties) jointly submit this Petition for Agreed Dismissal under Rule 260(b) of the South Carolina Appellate Court Rules.

The Parties tentatively have come to a settlement of the issues underlying CRCC's appeal to this Court and wish to pursue settlement outside of court. The Parties thus request this Court dismiss the appeal and remand the case to the Administrative Law Court (ALC) for approval of the Parties' consent order of dismissal.

Additionally, the Parties request that this Court hold the remittitur for at least thirty (30) days from the date of remand to allow sufficient time for the Parties to finalize the agreement. Once the ALC has entered a consent order of dismissal, the Parties will send the consent order to this Court and request the remittitur be sent to the ALC. The Parties also request that this Court return to CRCC its statutory appeal bond after the consent order of dismissal is entered by the ALC and contemporaneously when this Court sends the remittitur to the ALC.




