Good morning.

This is a follow-up to my correspondence to your office dated 09/04/2015 in regards to the 09/02/2015 deficiency reminder Notice from your office.

Please be advised that I recently reviewed the SC Judicial Department's website, and specifically, C-Track to review the current status of the instant appeal.
