
This is a response to a letter received from you on August 29, 2015 wherein to which the following deficiencies were alluded under the South Carolina Appellate Court Rules (SCACR):

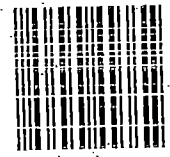
