Pardons, and Parole, South Carolina Commission on Indigent Defense


**COMES NOW** the Appellant, Jeffrey June, through his undersigned counsel, hereby  
moves this Honorable Court to dismiss the above-referenced appeal without prejudice.

The Appellant appeared in General Sessions Court in Sumter County on August 14, 2015  
for a hearing on his Violation of Probation. The Hon. Judge George James, Jr. found the  
Appellant's actions to be a willful violation and revoked four (4) years and terminated the  
Appellant's probation. Subsequently, the Appellant timely filed a Motion for Reconsideration on  
August 24, 2015. Additionally, the Appellant timely filed a Notice of Appeal on August 24,  
2015.





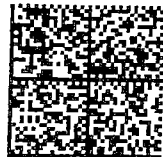
