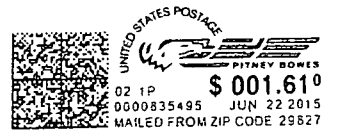

Notice is hereby given that Gary Slezak does hereby appeal the final decision of the South Carolina Department of Corrections dated 1/16/15 and received on 4/23/15 + 9/23/14, a copy of which is attached. A general statement of the grounds for appeal is (See S.C. Code Ann. § 1-23-380(A)(6)):

- 1) The South Carolina Department of Probation, Parole and Pardon Services Final Order is not supported by the evidentiary record or the substantial evidence as required by the APA and State Law See John Baptiste Castro v. Oregon Parole and Post Prison Supervision, 232 Or. App. 75, 220 P3d 777 (OR App 2009).
2. The Board failed to conduct a psychological evaluation before his parole review hearing as required by state law 9/15/14.
3. To the extent that the Board relied on factors that cannot be changed in the future (such as for example the nature of his crimes; the order violates his rights under the due process clause and exceeds the Board's statutory Authority by imposing the equivalent of a sentence of life without the possibility of parole.
