

The undersigned affirms that the foregoing fees and costs are correct and were necessarily incurred in this action. A copy of this statement has been mailed to opposing counsel.

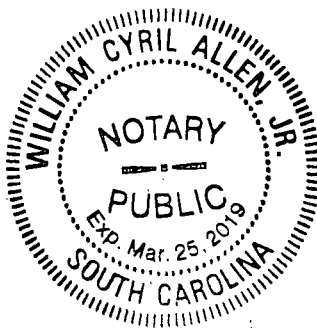

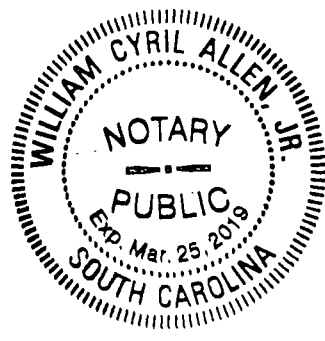
