The Initial Brief of Respondent in the above action is due to be filed September 14, 2015. Respondent's below-signed counsel submits that good cause has been shown:

I.

This motion is made because the Respondent has not been able to respond within the allotted time for the following reasons:

1. This matter was originally assigned to former Assistant Attorney General Kaycie Timmons who left employment on September 4, 2015 to become employed with the federal judiciary.

2. Below-signed counsel who has undertaken this briefing has had a number of other commitments in State and Federal court that have precluded timely completion of the Initial Brief of Respondent. Since the last request, below-signed counsel on August 3, 2015 filed a motion for summary judgment and memorandum of law in support in death penalty PCR action in John Wood v. State before Judge Mark Hayes; prepared a return and collateral motion for filing in death penalty PCR matter of Bayan Aleksey v. State on August 6, 2015; in Aleksey v. State on Aug. 14, 2015, filed a brief and return and motion for summary judgment in the federal habeas matter of Marcus Greene v. Warden on August 17, 2015; filed a motion and proposed order in death penalty PCR matter of Quincy Allen v. State on August 17, 2015; attended a South Carolina Common pleas Docket Management meeting on August 18; filed an Initial Brief of Respondent in the Court of Appeals in State v. Jeffrey Chronister on August 19, 2015; and, filed an Initial Brief of Respondent in State v. Kevin Howard in the Court of Appeals on August 26, 2015; on September 4, 2015 made a response to a federal habeas matter in Favian Hayes v. Warden, on September 4, 2015 made a 93 page Return and motion for summary judgment in Berry Bolin v. Warden, and on September 8, 2015 counsel filed a response to a motion to stay in the

death penalty matter of Bayan Aleksey v. State before the state court; a Return and motion for summary judgment in the federal habeas corpus matter of Christopher Ashe v. Warden .


