20 attorney one will be provided" -- excuse me --
21 "One will be provided at government expense
22 before you're questioned if you wish one. If you
23 decide to make a statement or answer a question
24 you have the right to stop at any time." Do you

19 date, which is going to be May 27th, 2008, and

20 I'm going to sign my name indicating that I

21 witnessed this signature. And then, let's see,

22 approximate time now is 22:50. Let me ask you,

23 now, y'all just went down to Myrtle Beach for how

24 long?

25 A: For two days.

1 Q: For two days?

2 A: Uh-huh (affirmative response).

3 Q: All right. And who all went with you?

4 A: It was my friend, Asia Jade Harris and Kim, I
5 don't know Kim's last name, and myself.

6 Q: All right. And Kim?

7 A: Uh-huh (affirmative response).

8 Q: And where did y'all stay at, do you remember?

9 A: We stayed at our friend's house, Chris, and my
10 friend's house, Vanessa, well, their hotel.

11 Q: Okay. They both live together or . . .

12 A: No.

13 Q: They live separate?

14 A: Yeah.

15 Q: Were both of them in a motel or y'all stay at
16 different places?

17 A: It was different places. Chris stay at another
18 place and Vanessa stayed at another.

19 Q: Okay. So y'all stayed at two separate places?

20 A: Yes, sir.

21 Q: I got you. I tell you what, what'll probably be
22 easier, why don't you -- and I think this will
23 make it easier, just tell me what you remember
24 leading up to the accident.

4 like a bunch of cars parked, like, on the grass,
5 so we thought we could park on the grass, but we
6 didn't know that it was the guy's house. And,
7 and, like, it was like three guys walked up. One
8 of them had on a blue collared shirt and the
9 other two had on a white t-shirt. And they was
10 like, "Y'all couldn't" -- "Y'all can't park here
11 unless you give us \$10.00."

12 And we was like, "Okay." And then two
13 other guys came up, two black guys came up with a
14 light, both of them had on light t-s. And they
15 was like, "Well, we're okay." So they parked,
16 and they was like, "We only have a 20. We don't
17 have a 10. Do y'all have change for a 20?" And
18 the other guy in the white shirt, he was like,
19 "No, we don't have change." And the guy in the
20 blue collared shirt, he was kind of drunk, he was
21 real, real drunk, and he was like, "Y'all can't
22 F-ing park here. Y'all need to move. Y'all
23 can't park here."

24 So his friend tries to get him to calm
25 down. So he pushed the black guy.

7 trying to calm him down, so he pushed the black
8 guy against our car. So they started fighting.
9 That's when the young man with the red collared
10 shirt on, they tried to break him up. So, all I
11 know is, they started fighting, then me and my
12 friend, we pulled off, and then we stopped
13 because we heard a gunshot. We was like, "Oh my
14 God. We heard a gunshot." So we stopped,
15 because we didn't know where they was shooting
16 from. So we just stopped. So we stopped behind
17 the, I guess their house they stayed in, and so
18 we stopped and then we pulled around and then we
19 seen the young, like the young guy in the red
20 collared shirt, he was laying on the ground. We
21 didn't know what, he was just, he fell, he was
22 unconscious, or we didn't know whether he was
23 dead or what. Then suddenly the ambulance and
24 the police came, and we tried, we found another
25 park, and we walked to Vanessa's hotel room, and

8 about 19, maybe.

9 Q: Tell me about his hair.

11 couldn't tell because he had like a hat on or
12 something.

13 Q: What kind of hat?

14 A: I want to say it was red and black, if I'm not
15 mistaken. It was dark. I, I want to say it was
16 red and black, it looked like.

17 Q: What was the logo on the hat?

18 A: I didn't see the logo. And I think he had on
19 shades, too.

20 Q: What was he, like, wearing the shades?

21 A: Yeah, wearing shades. They was dark colored
22 shades, like black or something.

23 Q: Okay. And so, what kind of shirt did he have on?

24 A: The black guy?

25 Q: Yeah.

7 he couldn't, you know, stand up he was so drunk.
8 So why the guy was talking and he, he was steady
9 trying to tell him that we couldn't park there.

11 man. We know. We know. Do you have change for
12 a 20?"

13 He was like, "No, but they can't F-ing
14 park here." So they started arguing and then the
15 guy, the white guy in the blue collared shirt, he
16 pushed the guy against the car and then got shot.

18 collared shirt started saying you couldn't park
19 there, and the black guy was saying, "We know.
20 We know." Tell me what was being said back and
21 forth.

22 A: Okay. The white guy in the collared shirt, he
23 was like, "Y'all can't F-ing park here." So then
24 when the black guy came over, he was like, "I'll
25 pay for the park." Do you have change for a 20?"




