I am in receipt of and thank you for the Court's letter of September 15, 2015, in regards to oral arguments to be scheduled this December, in the above referenced matter.

Please be advised that the only conflict I currently have is a Social Security Administration Office of Adjudication and Review Hearing scheduled on December 8, 2015, beginning at 10:30a.m., before the Honorable John R. Martin in Columbia, South Carolina. 
