




Dear Ms Kitchings:

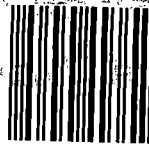
