This is in response to your letter of September 15, 2015, concerning a deficiency in my notice of appeal in the above-captioned case.


The order I attached to the notice of appeal is the only appealable order I received from the South Carolina Workers' Compensation Commission. I talked to a very helpful lady in your office who told me that the deficiency is that the notice of appeal reflects the South Carolina Uninsured Employees Fund as a party, but the order does not. She advised that I could remedy this problem by sending an order showing the proper caption, even if that order is not being appealed.

Attached is a Decision and Order issued on May 12, 2015 by a hearing Commissioner. This order is not appealable, of course, because it is not an order of the full Commission or an appellate panel of the Commission; but it does reflect the proper parties. I hope that this resolves the deficiency in the notice of appeal.
