



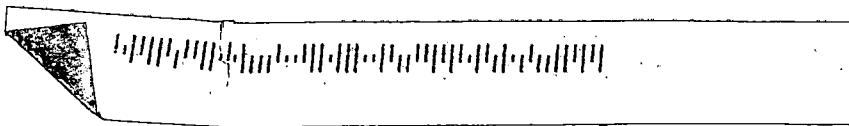
Removal documents divest of

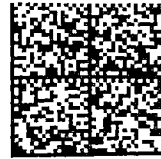
