That JAMES TYRONE GRAHAM did in Greenville County, between the 25th day of November 2011 and the 1st day of June 2012, engage in sexual battery with A.L., who was at least fourteen years of age but who was less than sixteen years of age, and that he did so in a position of familial, custodial, or official authority to coerce the victim to submit, and/or he was older than the victim. This is in violation of §16-3-655(B)(2) [formerly 16-3-655(3)] of the South Carolina Code of Laws (1976) as amended.
