EXTENSION OF TIME


Appellants, AMH-Ashley Marina, LLC and AMH Management, LLC, hereby





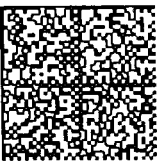
