Please file this petition within (15) fifteen days.

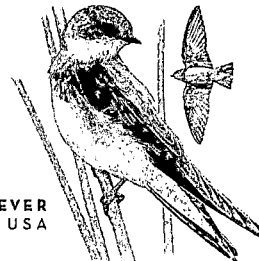

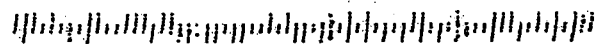
