
NOTICE





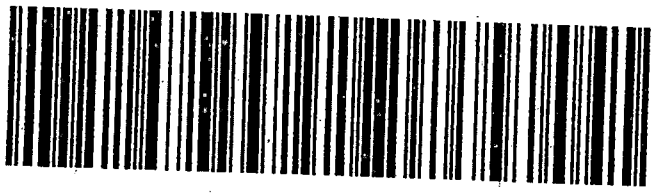
