

NOTICE OF APPEAL

Grace Covenant Tabernacle, Intervener/ Appellant, appeals the Order of the Honorable Deborah Brook Durden, Administrative Law Judge, filed March 25, 2015 (*copy attached*), her Amended Final Order and decision filed May 4, 2015 (*copy attached*), and the actions taken by the Department of Revenue after remand from the Administrative Law Court. NOTE. A prior appeal was dismissed by the Court of Appeals (*see attached Order*) because the case had been remanded to the Department of Revenue **“to investigate the two principals omitted from the application, namely the Petitioner’s daughter and John Greg.”** Appellant’s attorney sought to find out what was done afterward by the Department of Revenue but was informed that a Freedom-of-Information-Act (“FOIA”) request is required. In response to a FOIA request, the undersigned received a letter and two documents from the Department of Revenue on September 23, 2015. *See letter and two documents attached.*




