ORDER

Appellant has appealed the Administrative Law Court's order finding that the issues raised by Appellant did not bar the renewal of Respondent T MMark Industries, LLC's retail liquor license and remanding the case to Respondent South Carolina Department of Revenue "to investigate the two principals omitted from the application" and to grant or deny the license based on the results of the investigation. Because the ALC's order remands the case to the Department for further proceedings, the order appealed from is not immediately appealable. See S.C. Code Ann. § 1-23-610(A)(1) (Supp. 2014) (providing judicial review may only be sought from a final decision of the ALC); see also *Charlotte-Mecklenburg Hosp. Auth. v. S.C. Dep't of Health & Env'tl. Control*, 387 S.C. 265, 267, 692 S.E.2d 894, 894 (2010) ("If there is some further act which must be done by the court prior to a determination of the rights of the parties, the order is interlocutory."). Accordingly, this appeal is dismissed. The remittitur will be sent as provided in Rule 221, SCACR.
