
MOTION FOR COSTS

Pursuant to Rule 222, SCACR, Dharmendra Chaudhari requests that the costs of this appeal be taxed against South Carolina Uninsured Employers' Fund, who was the appellant.

Rule 222(a) provides that when a judgement is affirmed, costs shall be taxed against the appellant unless the court orders otherwise. This Court affirmed the judgment of the circuit court on January 28, 2015, and the Court issued the remittitur August 25, 2015. Because the Court has not ordered otherwise and because the parties have not agreed otherwise, the rule provides that the Court should award costs to Dharmendra Chaudhari, who is the respondent.




