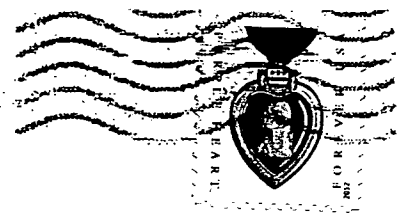


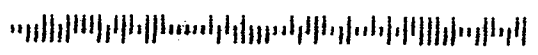


Dear George:
