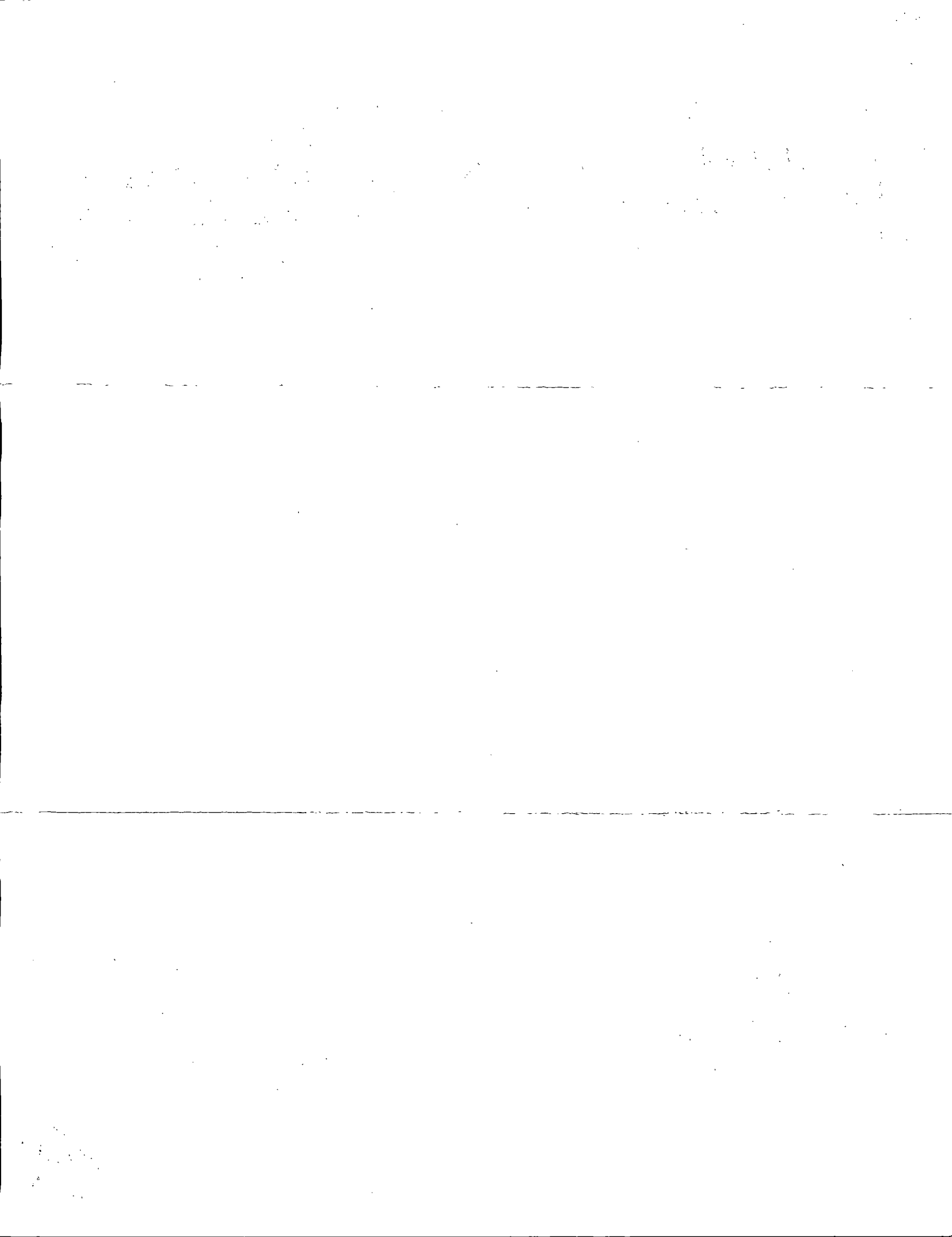

I Edward E. Baker II, am appealing Honorable Judge C. Lee, Circuit Court Judge sentence of 20 years for both assault 1st Degree of High Aggravated Nature. 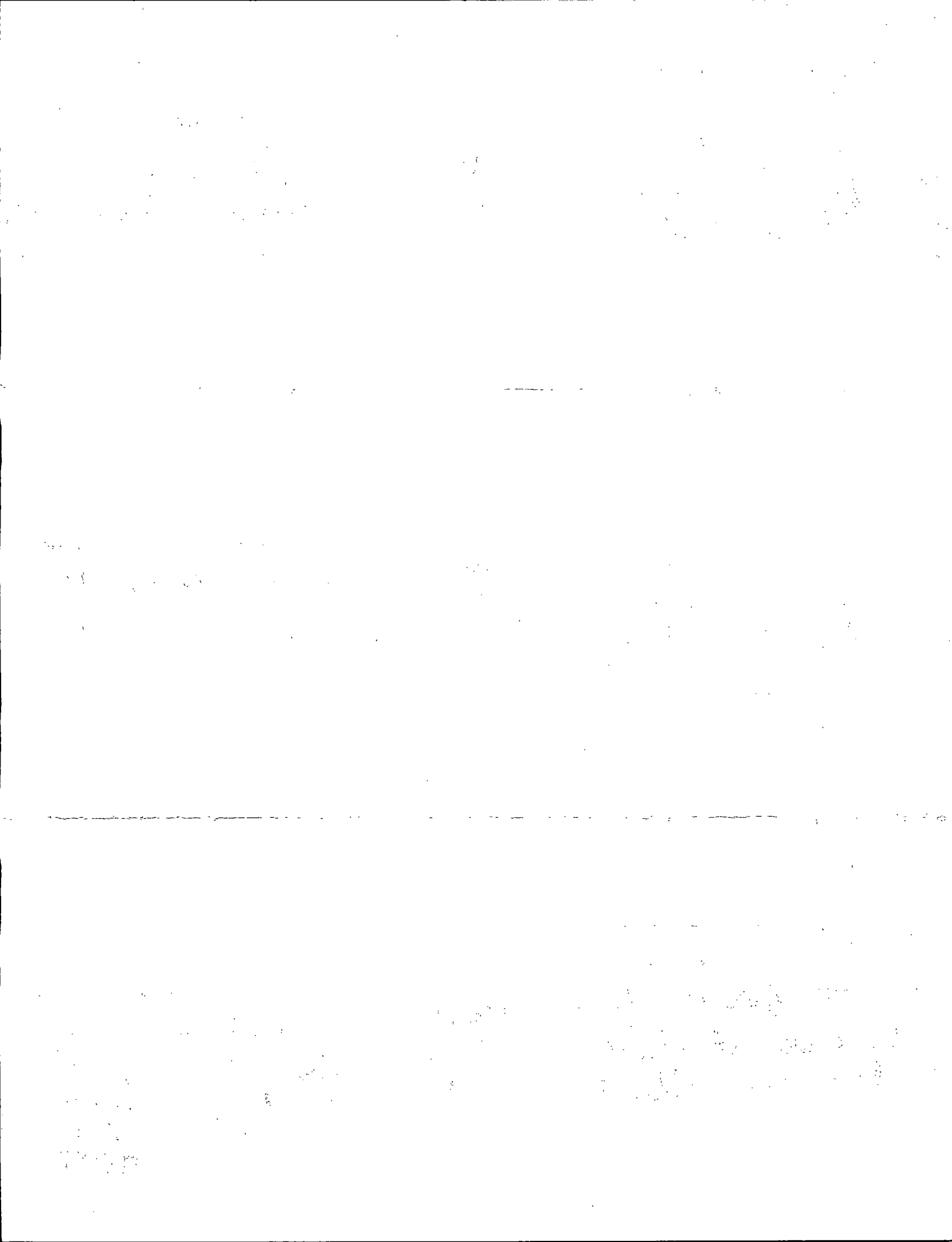

While I listened to my wife (Alafayette Baker) tell Jamoan to tell his mother that she would borderline fall in love with him, and that she wanted him.. My heart crumbled at that moment.. The love of my life was having an affair.. Nicole Simpson told another untruth on me saying I was using profanity on the Alvin S. Glenn Detention Center's phone.. On June 18th 2014 I called my wife (Alafayette Baker) to see if her and my son (Galen Johnson) were alright after the incident.. I asked my wife (Alafayette Baker) why was she cheating on me?? Her reply was talking aint fucking,, and I responded that it will lead up to it.. So to my knowledge all these lies helped me get the max of 20 years.. I was already in a bad situation as to the crimes I committed.. The Law says I couldn't get crime of passion,, because I didn't kill my wife.. I did apologize to Honorable Judge Lee, my wife (Alafayette - Baker), my son (Galen Johnson) and everyone who appeared at my plea hearing for having them there on my behalf.. I asked the Honorable Judge Lee if she could look in her heart to show leniency and mercy to give me another chance at life to make amends, compensate, and retribute my wife (Alafayette Baker) and son (Galen Johnson) for my wrong doings.. I vowed to stand by my family for the rest of my life whether we are together or not.. Now Kathryn Cavanaugh and Nicole Simpson did state that I was providing for my family while I was detained at Alvin S. Glenn Detention →

Center.. My wife (Alafayette Baker) lost her place of employment sometime in June 2015.. She didn't reveal this vital information to me until July 2015 once she had new employment set up at the V.A. Hospital.. Alafayette is a very beautiful woman and has claimed her independence now,, and makes it very hard to take money from me.. I had my last \$1200. dollars delivered to her.. \$300. was dropped off in June, and \$900. in July to help pay their electric bill, daycare, fees for summer camp, hair braiding sessions, and shoes for my daughters.. I explained to the Honorable Judge Lee that it wasn't easy to raise 4 children while my wife (Alafayette Baker) and I were together.. So I know its not easy for her alone.. I feel I owe my family a better life for my actions,, and willing to do whatever it takes to accomplish that.. I feel that my children Javion Johnson, Galen Johnson, Jewel Baker, and Jade Baker should not have to suffer along with me.. My Beautiful wife Alafayette Baker will replace me if she hasn't already.. That is a hard step that I have to live with everyday knowing my family will never be reunited..

In conclusion,, Mr Robert Dudek I hope and pray that you consider granting my appeal that way I can return to providing for my family like real men do.. Whether they need me or not I plan to be their back bone until my dying days.. If all else fails I plan to apply to prisons with work releases that way I can send money to my family weekly..
