As a follow up to my previous letter and to our recent telephone conversation, and your letter of September 22, 2015, please consider this letter my request that the Court of Appeals to amend the records to reflect Mr. Chisholm is pro se in this appeal and that I am not counsel of record for him.

I researched the fillings in Greenville County to determine how it is my name is designated as counsel for him in this circuit court action. Apparently when the divorce case ended we filed a transcript of judgment in the judgment roll in Greenville County. That judgment was from civil action 2001-DR-23-03596, and the entry of that judgment concluded our representation of Mr. Chisholm. Other than filing this transcript of judgment as part of our representation of Mr. Chisholm in the Family Court action, we did not take any other action related to the judgment roll or what became the circuit court action.


Apparently Mr. Chisholm, acting pro se, subsequently pursued supplemental proceedings. That process occurred under the civil action 2005-CP-23-06786 and is captioned "William B. Chisholm, Plaintiff, vs. Susan Elaine Chisholm, Defendant". The order now on appeal, and which generated appellate case number 2015-001708 is from those proceedings.

Based on these circumstances we respectfully renew our request that the Court of Appeals remove me as the designated counsel of record for Mr. Chisholm in this appeal. We have no attorney-client relationship with him and did not participate in the proceedings which led to the matter now on appeal.
