**PETITION FOR EXTENSION TO FILE

The undersigned counsel would respectfully request a **final thirty-day extension, until November 11, 2015**, in which to file the petition for writ of certiorari and appendix in the above-referenced case. In support of this motion, counsel would respectfully show the Court the following exigent circumstances:

1. The petition for writ of certiorari and appendix in this case are due to be served and filed today, having been extended by two prior orders of this Court.



State in the Supreme Court on August 28, 2015. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Terrance Johnson v. State in the Supreme Court on August 26, 2015. Counsel filed the brief of petitioner in the case of John Forest Ham, Jr. v. State in the Supreme Court on August 20, 2015. Counsel filed the final brief of appellant and designation of matter in the case of State v. Timmy Eugene Rice in the court of Appeals on August 20, 2015. Counsel filed Anders brief of appellant and designation of matter in the case of State v. Austen McKeever in the Court of Appeals on August 5, 2015.

3. This request is made in good faith, and not for purposes of delay. Counsel is striving to limit the number of extensions requested. Counsel is attempting to complete the cases with the most number of extensions first.


4. As indicated by consent below, counsel for the state graciously consents to or does not oppose this request.


