Hello. I am Larry Gambrell and I am timely filing a notice of appeal pursuant to S.C.A.C.R. Rule # 203 (b)(1). I am acting 'pro-se' in this matter. Pursuant to Rule 227(c), I am putting together a Writ of Certiorari.

Explanation Required: I recently on Aug. 6, 2015 received documentation from the Pickens County Clerks Office that my appointed counsel ~~before~~ trial secretly ceased her representation on my case, quit her job as a Public Defender and went to work as the prosecuting attorney in my case.
