

1. I am currently incarcerated and am in a constant state of poverty;
2. The records from the lower courts are voluminous and I will incur costs that I cannot afford;
3. This petition is for just cause and not for the purposes of delay; and
4. This petition is in the best interest of justice due to the fact that I have no other means at obtaining the lower courts records.

Therefore, I am respectfully demanding to proceed without costs and to have the records provided to myself and the Court at no cost.


