AMENDED NOTICE OF RECORD ON APPEAL

Torrance A. Gantt appeals the Conviction of Driving Under Suspension 3rd Order of case G185034Y15. The Order was imposed by Valerie Stroman of the Richland County Central Court on May 21, 2015. Appellant makes this request under good cause of this honorable court pursuant to reasons of the exclusionary rule of admissible evidence supporting a constitutional rule of law providing that otherwise admissible evidence may not be used in a criminal trial if it was obtained as a result of illegal police conduct. The search of my vehicle was unreasonable and illegal. In addition, my license was taken without a meaningful hearing as violation of due process, the fourth and fourteenth amendment of the United States Constitution. I also support this action in accordance with the Supreme Court of the United States opinions of Missouri v McNeely 596 U.S (2013) supporting constitutional rights that blood samples cannot be taken without warrant, and Bell v Burson 402 U.S 535 (1971) guaranteeing constitutional rights to the fourteenth amendment supporting that a driver's license cannot be taken away without sufficient due process including a meaningful hearing not just a formality. Under the ruling this order, again I was violated of constitutional rights to exclusionary rule, the fourth and fourteenth amendment of the United States Constitution after being pulled over by officer B.Trotter without probable cause, and arrested due to the initial violation of constitutional rights during an administrative action in which I was denied the right to a trial that I properly requested under South Carolina Code of Law and the opportunity to present this denial of due process to Valerie Stroman during the hearing of case G185034Y15.


