WITHDRAWAL OF MOTION TO STAY
And
ABANDONMENT OF BANKRUPTCY ESTATE INTEREST IN APPEAL

Robert F. Anderson, Chapter 7 Trustee ("Trustee") for the Chapter 7 Bankrupt Estate of Dorothy M. Simpson (the "Debtor") hereby files his Withdrawal Motion to Stay Appeal and submits the following:

1. The Debtor filed her petition for relief under Chapter 13 of the United States Bankruptcy Code (11 U.S.C. § 101 *et seq.*) on May 1, 2015 ("Petition Date") in the United States Bankruptcy Court for the District of South Carolina ("Bankruptcy Court").
2. On August 8, 2015, Robert F. Anderson, Chapter 7 Trustee for this Bankruptcy Estate, filed his Motion to Stay Appeal, while the Trustee attempted to determine the value, if any, of the Appeal to the Bankruptcy Estate.

3. On August 31, 2015, the Honorable Jasper Cureton Associate Judge, issued his Order staying the within appeal.

4. After application to the Bankruptcy Court, and after Notice and Opportunity for Hearing to the creditors of the Bankruptcy Estate, as defined in 11 U.S.C. §102(a), the Honorable Helen E. Burris, Judge of the United States Bankruptcy Court for the District of South Carolina, on October 2, 2015, issued her Order authorizing the Chapter 7 Trustee to abandon the within appeal.

5. The Trustee, with this document, and under the authority of the Order of October 2, 2015, herewith (a) abandons the Bankruptcy Estate's interest in that appeal, and (b) withdraws the Estate's Motion to Say Appeal.



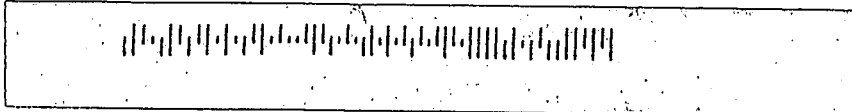

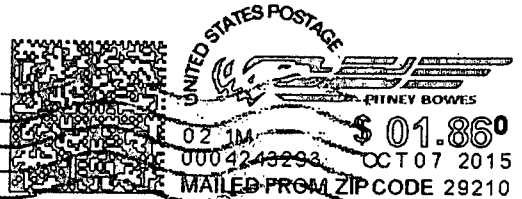
