We received your letter today notifying us that we have “thirty (30) days from the proof of service of the amended brief of petitioner to file their brief.”


We received Petitioner’s Motion to File the Amended Brief two weeks following his initial filing on or about September 25, 2015, with a copy of an amended brief. On that day, we filed our own motion for an extension of time to file the Respondent’s Brief, since Petitioner provided no insight into the actual changes made and we had performed a considerable amount of work as a result.

We received a call from Mrs. Allen regarding our Motion and were instructed that our time to file would begin to run after the disposition of the Petitioner’s Motion. Upon that notification, we withdrew our own request (by the attached email dated October 1, 2015) and performed no further work pending a decision from the Court on the Petitioner’s motion because of the uncertainty as to which brief would be permitted.

We respectfully request that the thirty-day time period begin to run as of the date of notice from the Court of its decision on the Petitioner’s motion, which would set the deadline for our brief to November 13, 2015.
