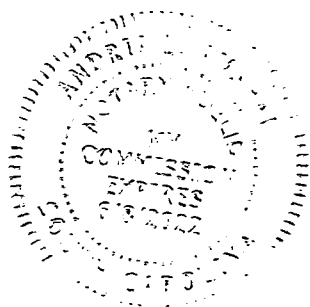
The orders or writ in this case has not been reduced to writing but has been declined. A copy of the order is attached to the application, without the writ or the order it will be prejudicial to the out come of case.
