This responds is to the information that I received on September 15, 2015, postdated September 10, 2015. I understand that I have a matter pending before your Court, Appellate Court case No. 2014-002325. I also understand that this case is under appellate review in my post-conviction relief, Case No. 2013-CP4006380. I also understand that this case related with my guilty plea in Richland County case no. 2011-GS400796. My concern is that I spoke with Mrs. Tynisha of the South Carolina Appellate Court on October 8, 2014 a few days after my court appearance before Honorable Robert E. Hoob's, that she could not find my Lexington Appeal, when I ask that she check under my case no. 2013-GS-32-00965 she told me that this case was under the cased file under case No. 2013-000642. Because both case's was done in Richland County. Appellate Case No. 2013-GS-32-00965 was remove from there computer. I've seen the paper work that was sent to me dated October 30, 2014. And the paper that I received Dated Oct. 30, 2014 I've never received until this day of Sept. 15, 2015. On or around Oct. 8, 2014 I sent Mrs Tynisha copies of Notice of appeal, Proof of service as well as copy of this information sent to Mrs. Jenny Abbott Kitchings ~~and~~ clerk of Court for Court of Appeals, and Mrs Beth Carrigg, Lexington Clerk of Court.

I was told that there was some errors made. I have a Remittitur Dated June 20, 2013 for Richland County Case No. 2013-GS-32-00965 Appellate Case No. 2013-000642. On September 17, 2013 I received a New Remittitur and was informed that the remittitur sent in June of 2013 contained a clerical error and that this remittitur reflected the correct trial court case number. Case no. 2011-GS-40-01996 Appellate Case No. 2013-000642.
