This letter is in follow-up to your conversation with my Paralegal, Ami Meetze, yesterday regarding the letter I received from you dated October 14, 2015 indicating that after review of my Notice of Appeal, a deficiency has been noted.

Please be advised that drafter of the Order before the South Carolina Workers' Compensation Full Commission erred in the caption of the Order. Specifically, the Decision and Order of the Appellate Panel of the South Carolina Workers' Compensation Commission dated September 3, 2015, does not include the South Carolina Uninsured Employers' Fund as a party to this action, however, the South Carolina Uninsured Employers' Fund was in attendance at the Appellate Panel Review held on June 15, 2015. I have attached hereto the Amended Request for Proposed Order from the Full Commission that does list the proper parties.

By carbon copy of this letter, I am hereby serving a copy of this letter upon all parties involved.

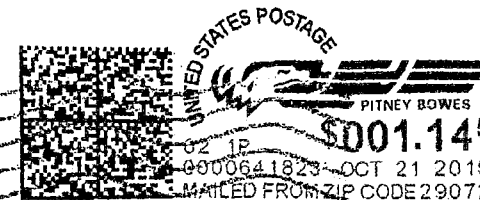
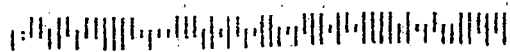
