to pay the initial filing fee AND ORDER THE  
transcript. In Addition I have forwarded your  
office A copy of a letter from Palmetto  
Health dated 10-8-15, In which they ASKed  
me to partake in A Survey AS I WAS A  
patient only days earlier. This is part of  
the proof AND Showing of Good faith that I

Am telling the truth. SCDC Records would reflect this information as well. Due to SCDC Security Policy I could not have known my Surgery dates in advance. Between the Surgery and hold over in Columbia for 2 weeks and with my mother's unfortunate task of dealing with the flood I was unable to get the payment in to your office as scheduled. I Thank you for your consideration with this request, and I have also sent a copy to ATTY. V. CLARK Price for the Respondents.
