

Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Kandy Gilliard v. State in the Supreme Court on September 14, 2015. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of John Thomas Robinson v. State in the Supreme Court on September 14, 2015. Counsel filed the Anders Brief of Appellant and designation of matter and Record on Appeal in the case of State v. Dwayne Chisoim in the Court of Appeals on August 28, 2015.

3. This request is made in good faith, and not for purposes of delay. Counsel is striving to limit the number of extensions requested. Counsel is attempting to complete the cases with the most number of extensions first.


4. As indicated by her consent below, counsel for the state graciously consents to or does not oppose this request.


