

Thank you for your letter. In order for us to accept your phone calls, you must record both your first and last name at the Department of Corrections as we have your name here in our files. You must record "Arthur Moseley".

The State's Response Brief will be against your issue because that is their job. Do not be surprised or offended by what they write.

We do not normally seek a bond for our appellate clients because they are incarcerated. Hence, they usually do not have the money to post an appeal bond.

Your case is in the beginning stages of your appeal. Once you filed the Notice of Appeal, I filed your Initial Brief; which I sent to you. Next, the State will file their Response Brief. Then it will take the Court of Appeals approximately a year to rule on your case. If they rule against you, I will file a petition for rehearing. Then if that is denied, I will file a petition asking the South Carolina Supreme Court to review your case. The Supreme Court may or may not decide to review your case.

If you do not win on direct appeal, your next step is to file a post conviction relief (PCR) application.

I hope this answers your questions.

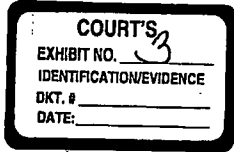



On June 19, 2002 Cooper arrived at the offices of the United States Attorney's Office, Florence, South Carolina, for his scheduled polygraph examination. Cooper was provided with a copy of an Advice of Rights form (FD-395) and a Consent to Polygraph form (FD-328), the contents of which were read aloud to him. Cooper advised that he understood his rights and demonstrated his willingness to proceed with the polygraph examination by signing both forms.

During the pretest interview, Cooper stated that he was present when Barrington and Singletary discussed retaliation for the theft. Cooper said that he recalled seeing Barrington pay Singletary approximately \$500, but could not recall if it was before or after the shooting.

A polygraph examination of Cooper was conducted utilizing the following relevant questions:

- A. Have you misled me today concerning the death of that man? (Answer - No); and
- B. Have you withheld any important information from me concerning the death of that man? (Answer - No).

Based on a review of the psychophysiological responses recorded during this examination, it is the opinion of this examiner that the recorded responses are not indicative of deception.

I have attempted without success to locate the remainder of the discovery documents that we do not have. I have enclosed a copy of everything we do have.


I have also enclosed the documents pertaining to the proffer agreement for Lonnie Dozier.

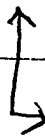

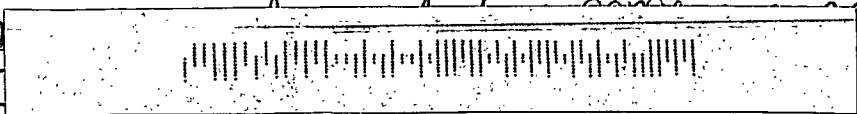

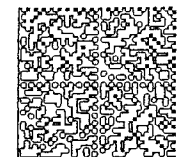
