Response petition as follows:

Please forward to my office any records maintained by your facility regarding Mr. Wade's medical treatment. Should you have any questions or concerns, please do not hesitate to contact me.

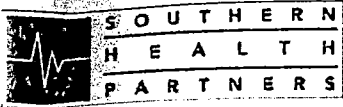
