That on 8/30/2012 between the hours of 0300 to 0600, near the North end of a path that runs on the East property line of the J.B. Beck Administration & Education Center property (between Legion Street and the 1900 block of Church Street), which is located within the city limits of Georgetown, SC, the defendant, Damonte Rivera, along with a codefendant, did willfully and unlawfully with malice aforethought, commit the offense of Murder by shooting Alphonso Thomas with a firearm causing death. The defendant was linked to the victim earlier on the night of 8/30/12 during the commission of an Armed Robbery. The defendant was also placed with the victim shortly before the shooting by witnesses, who also placed him and his codefendant in possession of a handgun. The defendant's alibi was proven to be false by witnesses and phone records. The defendant confessed about his participation in this homicide to another independent witness. This act being against the peace and dignity of the state of South Carolina.

On or about August 30, 2012 at approximately 0200 hours, the defendant, Damonte Rivera, and co-defendants did make unwanted forced entry into 622 South Kaminski Street Georgetown, South Carolina 29440 with the intent to commit armed robbery. The daughter of the residents was forcibly removed from her bed and dragged across the house at which time she was held against her will while one of the defendant's pointed a handgun at her head. Threats of death against the child were made if the victims did not comply with the defendants demands: The defendants demanded money from the victims. Money, cell phones, and car keys were stolen from the victims during the armed robbery. This incident occurred inside of a dwelling during the night hours while the residents were present.
