APPELLANTS MOTION FOR AN ORDER CONSISTENT WITH  
THE LOWER COURTS ORDER OF DISMISSAL OF CASE

To: Respondant State of South Carolina, Take Notice of this the following Motion, Appellant moves at this Courts earliest convience for the requested relief.

Now Comes Appellant, William Deans to move this Court pursuant to SCRCP, Rule 54(a) to fashion and issue an order closing this case / appeal that is consistent with the South Carolina Code of Law 44-48-80(A) ordered dismissal of this case in the lower court by Honorable Judge R. Stilwell residing.

See hereto, Appellants Exhibits (A-F), by reference,

(A) Clerk of Court, Anderson County, letter in response to Appellants attempt to file for process of a Subpoena for production of joined party Respondant, reply dated May 13, 2015.

(B) Appellants letter to Clerk of Court, Anderson County asking for a true copy of the referenced Judge Stilwell's Order of Dismissal and a Case History Index.

(C) Clerk of Court, Anderson County provided Case History Index dated produced on April 23, 2015.

(D) see Clerk Of Court, Anderson County provided an earlier Case History Index dated 3/26/2012.

(E) Letter dated July 13 2015 from Judge Stilwell declining to file Appellants request for processing of a Subponea for production of Joined Party.

(F) Letter of July 14, 2015 from Judge Maddox's office in response to Appellants Rule 5(e) request of Judge Stilwell to file and process a subpoena, including a personal observation of an out of state SVP case.

1. On Feb. 12, 2105, Appellant argued before Judge Stilwell on SCC Ann. 44-48-110 Annual Review Hearing, Judge Stilwell declined relief.

a) Appellant filed a timely SCRCP, Rule 59 Motion for Rehearing; To which there was no appearant ruling had been made, (until) Appellant was given Notice of the Dismissal.

2. Appellant did not become aware of the Dismissal of Case until (I) submitted a rquest for Clerk Of Court to process (pro-se) subpoena. Clerk of Court Anderson County declined to process the requested subpoena and gave Appellant

the Notice the case had been dismissed. See Appellants Exhibit (A).

3. Appellant then requested of Clerk of Court, Anderson County to provide a copy of the Case History Index and a copy of the Order of Dismissing this case. See Appellants Exhibit (B).

4. Clerk of Court provided a Case History Index dated as provided on April 23, 2015, with high lighted area showing the case having been Dismissed on Oct 31, 2002. See Appellants Exhibit (C) at high lighted area and see page 10/10 item # 17.

5. Compare Appellants Exhibit (D), a prior Case History Index provided to Appellant by Clerk of Court, Anderson County dated March 26, 2012 also documenting on page 1, Status of case Dismissed and see page 2 Case Dismissed at item # 6.

6. See Appellant Exhibit (E) letter reply of Judge Stilwell dated July 13, 2015. declining to file Appellants request for subpoena be filed and processed / including-agreeing to Appellants commenets on out of state SVP relevent case.

7. See Appellants Exhibit (F) it appears Judge Stilwell contacted Judge Maddox's office (un-solicitated by Appellant) who by letter informed Appellant of Judge Stilwells Dismissal and instructing Appellant to contact his attorney.

8. Appellants Exhibit (A,E,F) at present are the only documents confirming the Judge Stilwell Dismissal.

9. As mandated by this Court in *Buxton v Thompson Dental* 415 SE2d 844; Judge Stilwell's only allowable discretion was to correct any initial errors by enforcing the original order of Dismissal of Oct. 31, 2002. (1) see complimentary copy

Compare In Re: Care And Treatment Of Peter Harvey (SC 2003) 355 SC 53, 584 SE2d 893, where belated corrections were made by both the lower and this Court after a finding of errors made in the initial proceedings.

(1) complimentary copy of dismissal of Oct 31, 02 is not argued nor subject of this appeal, it is provided for a reference point and conveyance of the reader only.

As the facts and documentation show, the civil commitment case is now a moot issue leaving the lower court without the jurisdiction to even order Appellants release for being on appeal with Judge Stilwell replying on this Court to order Appellants release as mandated in *Kansas v Hendrick* 521 U.S. 346 at 361-362 holding,

"(a person) can not be detained past the time they are no longer dangerous or no longer have a mental illness".

"he is statutorily entitled to immediate release".

10. Appellant is entitled to his reasonable expectations to receive equal protection of the laws as afforded Buxton, Harvey, Hendrick, supra and should be ordered immediately released pursuant to South Carolina Code of Law 44-48-80(A) not to exclude any other provision of law.


PRAYER FOR RELIEF

This matter comes before me on petition of the State of South Carolina for an order finding that sufficient probable cause exists that the Respondent is a sexually violent predator as defined by South Carolina Code Section 44-48-30, and scheduling a hearing to contest probable cause.

I have reviewed the petition in this case and considered the showing made in respect to this matter and am of the opinion that the State has failed to demonstrate that probable cause exists to find that the Respondent is a sexually violent predator. I find that the State has failed to present sufficient evidence that the Respondent suffers from a mental abnormality or personality disorder that makes him likely to engage in acts of sexual violence if not confined in a secure facility for long-term control, care, and treatment as required by South Carolina Code Section 44-48-30(b). THEREFORE the State's petition in this matter is denied.

AND IT IS SO ORDERED.
