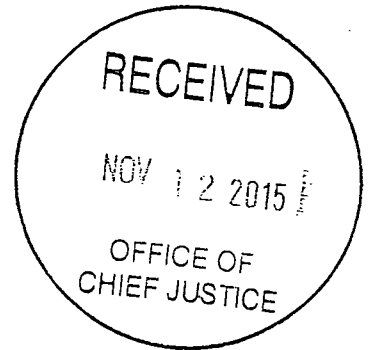

They refuse to send this, and it has made me miss my deadline in the Supreme Court, and now I have to ask for an extension.

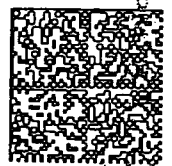

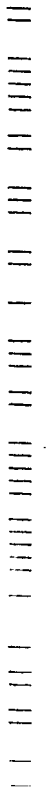
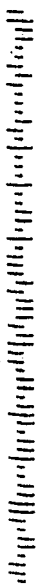
