MOTION FOR AN EXTENSION OF TIME

Counsel filed the brief of appellant and record on appeal in the case of State v. Tre'Vaughn Jackson with this Court on September 18, 2015. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Vernon Michael Wilcox v. State with the Supreme Court on September 8, 2015. Counsel is working on his error preservation presentation for a Public Defender Training on November 24, 2015. **Counsel has extensive administrative duties as the Chief Appellate Defender, including administrative and Appellate Project oversight, and, training three new appellate defenders and reading all of their writings.**

5. Counsel for the Attorney General's office consents to this request as shown by signature below.




