NOTICE OF APPEAL

Appellant DTZ, Inc., formerly known as UGL Services Unicco Operations Co. and formerly known as UNICCO Service Company (hereinafter "DTZ"), by and through its undersigned attorneys, Appeals the order of the South Carolina Procurement Review Panel dated October 12, 2015. Appellant received written notice of entry of this order on October 12, 2015. Appellant DTZ files this Notice of Appeal pursuant to S.C. Code Ann. §§ 11-35-4410(6) and 1-23-380 and South Carolina Appellate Court Rules 203 ("SCACR). Pursuant to S.C. Code Ann. §§ 11-35-4410(6) and 1-23-380, this appeal has been filed in the Court of Common Pleas for Richland County South Carolina as the Notice of Appeal and Petition for Judicial Review and Alternative Complaint for

Breach of Contract and Quantum Meruit Recovery. Pursuant to SCACR 203 this Notice is also filed with the Clerk of Court for the South Carolina Court of Appeals. 
