
Dear Ms. Stevens:



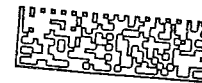
