Armed Robbery 16-11-330

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that such probable cause is based on the following facts:

The defendant, along with a co-defendant, did enter the Reis Gold and Silver Exchange, 2864 Rosewood Drive, in the city limits of Columbia, South Carolina, and while armed with knives, proceeded to rob the location of undetermined amount of property and currency. During the commission of the Armed Robbery, the owner of the location, William Reis, sustained multiple stab wounds resulting in his death. The defendant was apprehended a short distance away in possession of a bloody knife.
