

This is to acknowledge that on September 5, 2015, I received your letter requesting the Transcript of Record in the above matters. I have reviewed my records and estimate that the transcript will be approximately 63 pages.

Rule 607 provides that the rate of \$3.25 shall be charged per page for a transcript. Based on the current rate, the estimated cost will be \$204.75 (\$239.75 if e-mailed). Upon receipt of your check in the amount of \$204.75 (or \$239.75 for e-mail), I will be able to place your request in line for transcription. If the transcript is less than 63 pages, I will refund the difference to you upon delivery of the transcript. If the transcript is more than 63 pages, the balance will be due prior to delivery of the transcript.

Under our rules, I have sixty days in which to complete the transcript, after receipt of the deposit. In addition, I am allowed to request from Court Administration thirty day extensions if necessary to complete the transcript. You will be notified if extensions are granted.

If you desire to cancel the request for the transcript, a cancellation request must be made in writing. You will be responsible for payment of any portion of the transcript that has been completed.




