To assure that all of my meritorious issues are presented to the South Carolina Supreme Court, it is in my best interest to


proceed Pro Se.

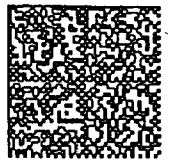
