

As grounds therefor Movants state:

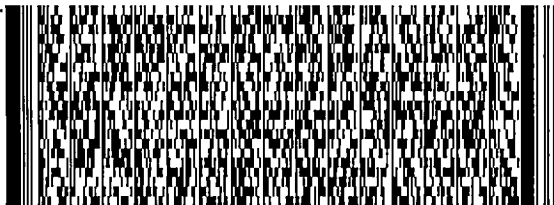
