Dear Ms. Kitchings:

On November 19, 2015, I received Mr. Cleveland's "Motion for Sanctions against Attorney Anne R. Culbreath." In September this Court advised Mr. Cleveland that it would take no further action on Mr. Cleveland's filings, therefore, I respectfully request that this correspondence serve as an informal response to this frivolous "motion." Mr. Cleveland has no appeal pending with this Court.
