

MOTION FOR EXTENSION OF TIME TO FILE RECORD ON APPEAL

Pursuant to Rules 263(b) and 240, SCACR, the undersigned counsel for Appellant respectfully requests an extension of the deadline for filing and serving the Record on Appeal. The deadline is currently September 9, 2015, if calculated from the date of the filing of Appellant's Initial Reply Brief (August 10, 2015), or September 18, 2015, if calculated from the date of the Court's Order consolidating this case with State v. Thompson (August 19, 2015). Appellant requests a thirty (30) day extension from the later date. With the extension, the new deadline would be October 19, 2015 (because October 18, 2015 is a Sunday). The grounds for this request are that the trial transcript is over 1,800 pages long—much of which has been designated for inclusion in the Record

on Appeal—and must be redacted prior to filing. Moreover, the undersigned is appointed counsel as part of the 2014 Appellate Practice Project and, given the other demands of his practice, needs additional time to prepare the Record on Appeal, especially in light of the required redaction. The undersigned has consulted with Amie L. Clifford, Esquire, counsel for Respondent, who indicated she has no objection to this request.


